The following criteria will be combined in awarding the Scholarship Program:

Credit Union Membership

Candidates must be members in good standing of Lakeland Credit Union Ltd. for at least six months prior to the application date or parents/guardians must have been members in good standing for one year prior to the application date.

Education

Candidates must have received (or be eligible to receive during the year of application) a valid Alberta High School Diploma.

Statement of Marks

All candidates **must** supply an official transcript of all high school credit courses to date and copy of latest apprenticeship report. Statement of marks must be **signed** by your Career Counsellor, Principal, or Vice-Principal.

Eligible Institutions or Course of Studies

Candidates may be enrolled in their first year of studies at any recognized and accredited post-secondary institution in Canada to study on a full-time basis. In the case of the Apprenticeship Program, the institution must be accredited and/or a recognized Vocational School.



Selection Criteria

The scholarship will be awarded based on a number of factors, which include leadership, community/school involvement, educational and future goals, academic achievement, personal submission and letters of recommendation as noted below. Candidates may only receive this award once. Additional consideration will be given to those students who submit a digital personal submission.

Personal Submission

Candidates' personal submission should include an essay of no more than 500 words providing a personal introduction to the candidate highlighting their values and personality.

Topic Based Presentation

You may choose one of the following topics to present on:

- How can Canadian credit unions best maximize the value they provide to students, families and their communities?
- In a perfect world, how would you do your "banking"? Why?
- What are the benefits of the credit union/cooperative business model and how can we effectively share this with others?

Presentation of the applicants choice of the following options on one of the below listed topics:

- Essay of 500 words or less;
- 3 to 5 minute video;
- Electronic presentation of at least 15 slides.

Letters of Recommendation

Candidates must supply at least **two** letters of recommendation, one of which shall be preferably from their school principal, teacher or professor/instructor and the other from a community involvement group leader or an employer, if the applicant has a part-time job or apprenticeship sponsor. Letter must include applicant's leadership, community/school involvement and future goals.



Selection Decision

The selection of successful candidates will be made by a selection committee chosen by the Board of Directors of Lakeland Credit Union Ltd. Their decision is final and not open to debate. Applications and accompanying documentation will not be returned to the applicants.

Release Agreement

The recipient of the award must agree to have their name and photograph published in any and all media channels employed by Lakeland Credit Union. Submission of application will constitute agreement that Lakeland Credit Union becomes the owner of all submission material to be used for communication purposes, both internally and externally.

Enrollment Confirmation

Applicants must confirm enrollment in an approved educational institution before receiving payment of the scholarship must be used within the next school calendar year.
